# MINUTES CONCORD TOWNSHIP BOARD OF TRUSTEES REGULAR SESSION NOVEMBER 28, 2018

The Concord Township Board of Trustees met in regular session at 10:00 a.m. on Wednesday, November 28, 2018 in the Township Building. Bill Whidden called the meeting to order, led the Pledge of Allegiance, and the roll was called. Trustees Bill Whidden, Don Pence, and Tom Mercer were present. Fiscal Officer Pat Quillen was also present, but Road Superintendent Neil Rhoades was out on leaf collection.

<u>Minutes:</u> Tom Mercer made a motion to approve the Minutes of November 14, 2018 as distributed. Don Pence seconded the motion and all three Trustees signed in favor.

<u>Guests:</u> Miami County Sheriff's Deputy Eric Brazel reported that all is quiet in the Township. Tom Mercer stated that the Trustees are very grateful to Miami County Sheriff Dave Duchak for all of his support and help with enforcing the Resolutions that have been put into place.

# Fiscal Officer's Report: Pat Quillen

<u>Communications:</u> The Trustees reviewed the items listed on the Agenda. Don Pence noted Ohio Township Association Winter Conference registration deadlines published in the <u>Grassroots Clippings</u> Newsletter and asked that the issue be put on the Agenda for December 12. None of the other items required action and none was retained.

**Road Superintendent's Report:** Tom Mercer reported that he had spoken with Neil Rhoades who estimated that there may be 20 loads of brush still out to be collected. The staff is a couple of days behind on leaf pickup. Tom Mercer will meet with Neil Rhoades to discuss the timelines.

### **Old Business:**

- A. Resolution 2018-07 To Amend the Personnel Policies and Procedures Manual to include Job Descriptions: Don Pence reviewed the process of drafting the Job Descriptions based on the recommendations of KLA Risk Consulting on behalf of the Ohio Township Association Risk Management Authority (OTARMA). Don Pence made a motion to adopt the Resolution which includes job descriptions for Road Superintendent, Assistant Road Superintendent, Road Worker Full Time-Part Time, and Temporary/Seasonal Worker. Bill Whidden supported the motion and the Resolution passed unanimously in favor by signature.
- B. Cell Phone Safety Amendment to the Personnel Policies and Procedures Manual: The Trustees discussed the possibility of adding language to address texting, both sending and receiving. Changes were made to the draft presented at the last meeting and will be incorporated into a Resolution for adoption at at the next meeting.
- C. Storm Water: At the recent 3<sup>rd</sup> Generation Stormwater Management Plan meeting, Tom Mercer inquired if Concord Township's participation in the Valpak mailing would meet the public education requirement. Members of the Miami Soil & Water Conservation District stated that they need to be able to verify how many people received the message. Linda Raterman from MS&WCD will contact Valpak for information. Tom Mercer also reported that the Storm Water Annual Meeting will be held on December 12 at the Miami County Engineer's Garage and our staff members will attend. Additionally, Miami County will be enforcing the use of silt fences at construction sites. All information for the Annual Report must be submitted to Kreig Smail at MS&WCD in January for his April report.

- A. <u>Purchase Order 10-2018</u> in the amount of \$6,370.98 for the additional paving cost was presented. Tom Mercer made a motion to approve the P.O. and was seconded by Bill Whidden. All three Trustees signed in favor.
