## RESOLUTION 2013-10 PARKING REGULATION RESOLUTION

WHEREAS, Section 505.17 of the Ohio Revised Code empowers the Board of Trustees to make such regulations and orders as necessary to control all vehicle parking in the Township; and,

WHEREAS, the Board of Trustees is of the position that it is in the best interests of the public safety and welfare and essential that on-street parking of specific vehicles be regulated,

NOW, THEREFORE, BE IT RESOLVED by the Concord Township Board of Trustees:

1) No person shall park or permit the parking of any motor vehicle having motor power and used as a commercial vehicle or a commercial tractor and/or trailer to be parked on any street in a residential subdivision of the Township unless the vehicle is being utilized to provide service in the immediate area. Commercial vehicles that may be called to respond to emergencies by local law enforcement, and must therefore be immediately accessible, would be exempted from this requirement.

2) No person shall park, or permit to remain parked, a trailer, semi-trailer, travel trailer, house trailer, recreational vehicle, camper, truck camper, boat, boat trailer, or mobile home on any street in a residential subdivision of the Township except when continuously and actively engaged in loading or unloading goods from such equipment or vehicle.

3) Any of the above enumerated vehicles or types of vehicles or combination thereof parked in violation of this order will be served with written notice of such violation. Violators will be guilty of a minor misdemeanor and subject to a fine.

Parking regulations authorized and adopted by this Resolution shall be applicable to all established roadways within the township which are proximate to buildings on private property, including those listed on the attached Exhibit A, but shall not apply to any state highway.
